3. **L23-163 - Caldwell Parish Police Jury**  
5.56 mills tax, 10 years, 2026-2035, acquiring, construction, improving, operation and/or maintaining public recreational facilities.
4. **L23-165 - Cameron Parish Police Jury**  
(1) 2.64 mills tax, 10 years, 2024-2033, maintaining and operating the Courthouse and Jail; (2) 1.32 mills tax, 10 years, 2024-2033, supporting the Health Center; (3) **Consolidated Garbage District No. 1** - 7.86 mills tax, 10 years, 2025-2034, providing and maintaining garbage collection and disposal services.

6. **L23-161 - Lafayette Parish Assessment District**

**12. S19-016A - Louisiana Housing Corporation (Hollywood Acres Project)**

Not exceeding \$1,000,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 45-unit multifamily housing facility for seniors in Baton Rouge.

**13. S23-029 - Louisiana Housing Corporation (Vineyards at Iowa Project)**

Not exceeding \$13,250,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 70-unit multifamily housing development in the Town of Iowa.

**14. S23-030 - Louisiana Housing Corporation (Renaud Place Townhomes Project)**

Not exceeding \$13,750,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 70-unit multifamily housing development in Lafayette.

**15. S23-031 - Louisiana Housing Corporation (King Oaks V Project)**

Not exceeding \$12,000,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquiring, constructing, and equipping a 70-unit multifamily housing development in Shreveport.

**16. S23-032 - Louisiana Housing Corporation (Galilee City Apartments Project)**

Not exceeding \$11,800,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquiring, constructing, rehabilitation and equipping a 76-unit multifamily housing development in Shreveport.

**17. S23-033 - Louisiana Housing Corporation (Lakeside Garden Apartments Project)**

Not exceeding \$21,350,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquiring, constructing, rehabilitation and equipping a 110-unit multifamily housing development in Shreveport.

**18. S23-034 - Louisiana Housing Corporation (Landry Commons Project)**

Not exceeding \$17,500,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 96-unit multifamily housing development in Lafayette.

**19. S23-035 - Louisiana Housing Corporation (Loop Commons Project)**

Not exceeding \$17,500,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 96-unit multifamily housing development in Lafayette.

**20. S23-036 - Louisiana Housing Corporation (Parkway Commons Project)**

Not exceeding \$10,500,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 48-unit multifamily housing development in Lake Charles.

**21. S23-037 - Louisiana Housing Corporation (Ridge Commons Project)**

Not exceeding \$17,500,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquisition, construction, and equipping of a 96-unit multifamily housing development in Lafayette.

**22. S23-038 - Louisiana Housing Corporation (Highland Place Townhomes Project)**

Not exceeding \$11,500,000 Multifamily Housing Revenue Bonds (Volume Cap), not exceeding 10%, not exceeding 40 years, acquiring, constructing, and equipping a 70-unit multifamily housing development in Monroe.

**23. S23-039 - Louisiana Community Development Authority (Cypress West Apartments Project)**

Not exceeding \$48,000,000 Multifamily Housing Revenue Bonds, not exceeding 12%, not exceeding 40 years, (1) acquisition, rehabilitation and equipping of a 452-unit multifamily housing complex in Westwego and (2) funding reserves.

**24. S23-040 - Louisiana Community Development Authority (NB Affordable New Orleans Portfolio Project)**
